WITNESSETH

5. That the exhibit booth will be ready in the morning of August 15, 2016 and that the EXHIBITOR will exert effort to complete their display before 12:00 Noon of August 16, 2016 in order not to disrupt the other EXHIBITORS and the convention proper itself.

6. That the EXHIBITOR agrees to respect the agreement between PHILSUTECH and the Exhibit Booth Owner, more specifically as follows:

a) That the EXHIBITOR will not paint, staple, thumbtacks, or alter any of the wooden panels or structural extrusions in anyway. Any damage that might be incurred by the EXHIBITOR will be charged accordingly to the EXHIBITOR as per following charges:

P 2,000.00	- for every wooden panel
P 2,000.00	-for every structural extrusion
P2,000.00	-for every fascia board

b)Any losses of materials or part of the EXHIBIT BOOTH will be charged to EXHIBITOR as per following charges:

P 3,500.00	-Aluminium post
P3,000.00	-Aluminium beam
P3,000.00	-Plywood panel
P3,000.00	-Fascia Board

7. That the EXHIBITORS agree to respect the agreement between PHILSUTECH and the Waterfront Hotel, Lahug, Cebu City, more specifically as follows:

- 1) The EXHIBITOR is only allowed to bring in food and/or beverage within the booth for consumption of the three (3) watchers. Candies and chocolates will also be allowed within the premises of the booth.
- 2) Nailing and tacking on the walls or floors is not allowed. Flammable materials should not be stored in the exhibit area.
- 3) A list of personnel and equipment of the EXHIBITOR shall be submitted to the hotel management for security and gate control purposes, not later than August 1, 2016.
- 4) The demonstrations of exhibits may be allowed provided it does not threaten the security or person or property or cause annoyance to the neighboring exhibitors and/or the general public.
- 5) Entry into or display at the hotel premises of the following are prohibited, unless allowed in writing by the hotel management and government agency concerned.

- a) Arms, guns, ammunitions, explosives, inflammables, radioactive materials and goods of dangerous nature.
- b) Goods prohibited for import or domestic sales.
- c) Goods that infringe upon other persons patiens.
- d)Goods disallowed by government laws.
- e) Goods which the hotel management considers as hindrance to the smooth operation of the hotel.

6)The hotel management shall exercise full authority within the hotel premises and reserves the right, from Ingress to Egress to control, regulate, inspect refuse entry to or exhibit any exhibit, display goods and/or materials which constitutes violation to Philippine laws.

10) While every precaution will be taken to protect the exhibit items and equipment the EXHIBITOR hereby accepts that neither the hotel management nor PHILSUTECH will be held responsible for losses and/or damages due to human factor and/or force of nature, fire or other causes not attributable to them.
